California's International Affairs and Trade Development Interagency Committee

California's International Affairs and Trade Development Interagency Committee held their first committee meeting on May 30th. Given the Lieutenant Governor's experience as a U.S. Ambassador, she will oversee international affairs and trade development initiatives for the Newsom administration, with the aim of maintaining California's leadership on the international stage. To that end, the Committee was established by way of Governor Newsom's Executive Order and chaired by Lt. Governor Kounalakis and vice-chaired by the Governor's Chief Economic and Business Advisor Lenny Mendonca. The Committee will serve as the coordinating body for the Governor's administration on the promotion and expansion of trade, investment and international relations. Members include the California Energy Commission, California Department of Food and Agriculture, the Governor's Office of Emergency Services, the California Environmental Protection Agency, California Natural Resources Agency, California State Transportation Agency, Visit California, and GO-Biz. The committee is charged with increasing California's global presence and reopening international trade offices. California to apply for U.S. Small Business Administration's STEP Funding Opportunity

The State Trade Expansion (STEP) grant program has been approved by Congress for appropriation of the 8th year for \$18 million. GO-Biz, in partnership with the California Department of Food and Agriculture, will be applying for a \$900,000 competitive grant. These federal funds will help small businesses increase international sales exports to foreign markets and contribute to economic growth in California. The application is due June 7, 2019.

The State of California has received approximately \$6.45 million since the inception of the STEP program in 2011, which has helped to provice thousands of California small businesses access to international trade opportunities – more than 900 of which have participated in overseas exhibitions that generated more than \$62 million in export sales.
